## SECTION 4: First aid measures

### **Description of first aid measures**

#### **If inhaled**

Move the victim into fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration and consult a doctor immediately.

Do not use mouth to mouth resuscitation if the victim ingested or inhaled the chemical.

#### **Following skin contact**

Take off contaminated clothing immediately. Wash off with soap and plenty of water. Consult a doctor.

#### **Following eye contact**

Rinse with pure water for at least 15 minutes. Consult a doctor.

#### **Following ingestion**

Rinse mouth with water. Do not induce vomiting. Never give anything by mouth to an unconscious person. Call a doctor or Poison Control Center immediately.

### **Indication of any immediate medical attention and special treatment needed**

Basic treatment: Establish a patent airway. Suction if necessary. Watch for signs of respiratory insufficiency and assist ventilations if

necessary. Administer oxygen by nonrebreather mask at 10 to 15 L/min. Monitor for pulmonary edema and treat if necessary . Monitor for shock and treat if necessary . For eye contamination, flush eyes immediately with water. Irrigate each eye continuously with normal saline during transport . Do not use emetics. For ingestion, rinse mouth and administer 5 ml/kg up to 200 ml of water for dilution if the patient can swallow, has a strong gag reflex, and does not drool. Administer activated charcoal . Aromatic hydrocarbons and related compounds

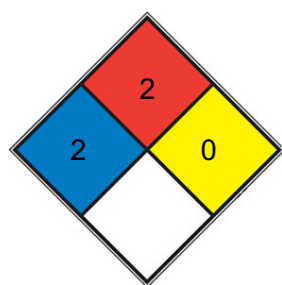

### **Toxicity**

Toxicity to fish: LC50 *Pimephales promelas* (fathead minnow) 4.15 mg/l/96 hr (confidence limit 4.05 - 4.25 mg/l), flow-through bioassay with measured concentrations, 23.5 deg C, dissolved oxygen 7.5 mg/l, hardness 45.8 mg/l calcium carbonate, alkalinity 42.2 mg/l calcium carbonate, and pH 7.28.

### **Persistence and degradability**

1,3-Diethylbenzene at a concn of 0.5 ppm C was completely removed within 5 days from a gas oil mixture added to acclimated fresh-wellwater grab samples from Tuffenwies and Zurich, Switzerland, with a pH of 8.0, at 10 and 25 deg C and microbial populations of 300-400 cells/ml(1).

A gas oil sample with an overall concn of 0.5 ppm contained 1,3-diethylbenzene, which degraded at a moderate rate in North Sea coastal water maintained at 20 deg C for 14 days(2).

### **Bioaccumulative potential**

An estimated BCF of 520 was calculated for 1,3-diethylbenzene(SRC), using a log Kow of 4.44(1,SRC) and a regression-derived equation(2). According to a classification scheme(3), this BCF suggests the potential for bioconcentration in aquatic organisms is high.

### **Mobility in soil**

Using a structure estimation method based on molecular connectivity indices(1), the Koc for 1,3-diethylbenzene can be estimated to be 1600(SRC). According to a classification scheme(2), this estimated Koc value suggests that 1,3-diethylbenzene is expected to have low mobility in soil.

### **Disposal methods**

#### **Product**

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

#### **Contaminated packaging**

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
