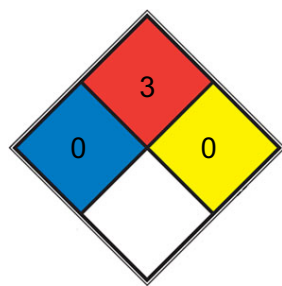

**Waste treatment methods**
