## SECTION 4: First aid measures

### **Description of first aid measures**

#### **If inhaled**

Move the victim into fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration and consult a doctor immediately.

Do not use mouth to mouth resuscitation if the victim ingested or inhaled the chemical.

#### **Following skin contact**

Take off contaminated clothing immediately. Wash off with soap and plenty of water. Consult a doctor.

#### **Following eye contact**

Rinse with pure water for at least 15 minutes. Consult a doctor.

#### Following ingestion

Rinse mouth with water. Do not induce vomiting. Never give anything by mouth to an unconscious person. Call a doctor or Poison Control Center immediately.

#### Indication of any immediate medical attention and special treatment needed

Basic treatment: Establish a patent airway. Suction if necessary. Watch for signs of respiratory insufficiency and assist ventilations if necessary. Administer oxygen by nonrebreather mask at 10 to 15 L/min. Monitor for shock and treat if necessary. Anticipate seizures and treat if necessary. For eye contamination, flush eyes immediately with water. Irrigate each eye continuously with normal saline during transport. Do not use emetics. For ingestion, rinse mouth and administer 5 ml/kg up to 200 ml of water for dilution if the patient can swallow, has a strong gag reflex, and does not drool. Administer activated charcoal. 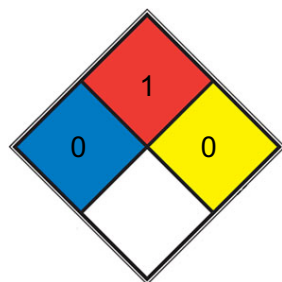

## SECTION 6: Accidental release measures

### **Personal precautions, protective equipment and emergency procedures**

Avoid dust formation. Avoid breathing mist, gas or vapours. Avoid contacting with skin and eye. Use personal protective equipment. Wear chemical impermeable gloves. Ensure adequate ventilation. Remove all sources of ignition. Evacuate personnel to safe areas. Keep people away from and upwind of spill/leak.

## Persistence and degradability

AEROBIC: 2-Isopropylnaphthalene may degrade in the environment based on data from analogous 1- and 2-methylnaphthalenes(1). Less than 5% and 5% degradation of 1- and 2-methylnaphthalene, respectively, occurred in 28 days using the Japanese MITI I procedure; however, for the MITI II test with a freshwater inoculum, 49% and 72% for 1- and 2-methylnaphthalene, respectively, was lost in 28 days under aerobic conditions at 25 deg C(1).

## Bioaccumulative potential

An estimated BCF of 730 was calculated for 2-isopropylnaphthalene(SRC), using an estimated log Kow of 4.6(1) and a regression-derived equation(2). According to a classification scheme(3), this BCF suggests the potential for bioconcentration in aquatic organisms is high(SRC). However, using a bioaccumulation study, 2-isopropylnaphthalene was not detected in oyster tissue samples following a 14 day exposure to 2-isopropylnaphthalene-contaminated sediment (concn of <10 ng/g dry wt) collected near Port Lachon, LA(4).

## Mobility in soil

Using a structure estimation method based on molecular connectivity indices(1), the Koc for 2-isopropylnaphthalene can be estimated to be 9,000(SRC). According to a classification scheme(2), this estimated Koc value suggests that 2-isopropylnaphthalene is expected to be immobile in soil.

## Disposal methods

### Product

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

### Contaminated packaging

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
