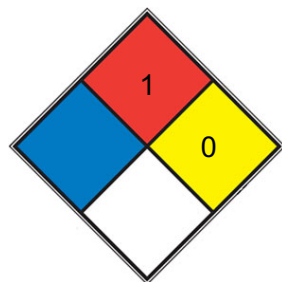
Advice for firefighters

SECTION 6: Accidental release measures
