#### General advice

Hydrofluoric (HF) acid burns require immediate and specialized first aid and medical

After eye contact: rinse out with plenty of water. Immediately call in ophthalmologist. Remove contact lenses.

#### If swallowed

After swallowing: make victim drink water (two glasses at most), avoid vomiting (risk of perforation). Call a physician immediately. Do not attempt to neutralise.

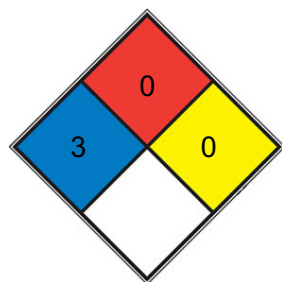
