An estimated BCF of 15 was calculated for indalone(SRC), using an estimated log Kow of 2.42(1) and a regression-derived equation(2). According to a classification scheme(3), this BCF suggests the potential for bioconcentration in aquatic organisms is low.

Mobility in soil

Using a structure estimation method based on molecular connectivity indices(1), the Koc for indalone can be estimated to be 10(SRC). According to a classification scheme(2), this estimated Koc value suggests that indalone is expected to have very high mobility in soil.

Product

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
