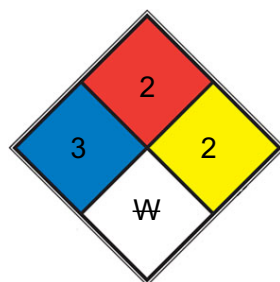

SECTION 6: Accidental release measures

Personal precautions, protective equipment and emergency procedures
