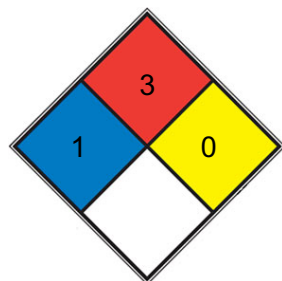

## SECTION 13: Disposal considerations

### Waste treatment methods
