### Description of first aid measures

#### If inhaled

Move the victim into fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration and consult a doctor immediately. Do not use mouth to mouth resuscitation if the victim ingested or inhaled the chemical.

Rinse mouth with water. Do not induce vomiting. Never give anything by mouth to an unconscious person. Call a doctor or Poison Control Center immediately.

#### Indication of any immediate medical attention and special treatment needed

Maintain an open airway and assist ventilation if necessary. Administer supplemental oxygen. Treat seizures, coma, hypotension, hypertension, and arrhythmias if they occur. Observe for at least 4 to 6 hours to rule out delayed toxicity, especially after skin exposure. For ingestion of intact gum, tablets, or transdermal patches, observe for a longer period (up to 12-24 hours). Mecamylamine (Inversine) is a specific antagonist of nicotine actions; however it is available only in tablets, a form not suitable for a patient who is vomiting, convulsing, or hypotensive. Signs of muscarinic stimulation (eg, bradycardia, salivation, wheezing), if they occur, may respond to atropine. Nicotine


