## SECTION 4: First aid measures

### **Description of first aid measures**

#### **If inhaled**

SYMPTOMS: Symptoms of exposure to this compound may include respiratory distress, depression, dizziness, faintness, lightheadedness, unsteadiness, dyspnea, headache, nausea, abdominal cramps, liver and kidney damage, vomiting and weakness. ACUTE/CHRONIC

HAZARDS: When heated to decomposition this compound emits very toxic fumes of disodium oxide, sulfur oxides and nitrogen oxides. (NTP, 1992)

## SECTION 6: Accidental release measures

### Personal precautions, protective equipment and emergency procedures

Remove all sources of ignition. Evacuate personnel to safe areas. Keep people away from and upwind of spill/leak.

Flammable gases are formed by mixing materials in this group with alkali metals. Explosive combination can occur with strong oxidizing agents, metal salts, peroxides, and sulfides.
