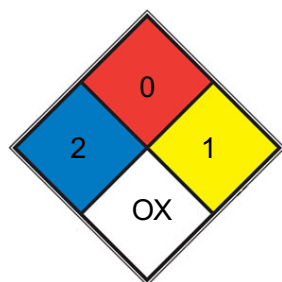

Lead dioxide is a powerful oxidizer. Violent reaction with many compounds, including reducing agents; chemically active metals; combustible materials, strong acids, alkaline earth sulfides, aluminum carbides, aluminum, amines, chlorine trifluoride, glycerin, hydrides, hydrochloric acid.

Waste Disposal

Conversion to soluble salt, precipitation as sulfide and return to supplier. Do not discharge into drains or sewers. Dispose of waste material as hazardous waste using a licensed disposal contractor to an approved landfill.
