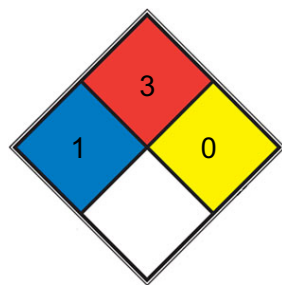

#### Waste Disposal
