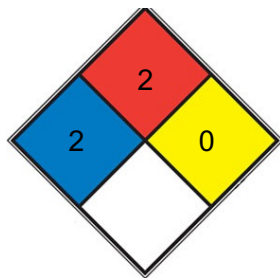

Osmium tetroxide is a strong oxidizer. Reacts with combustibles and reducing materials. Reacts with hydrochloric acid to form toxic chlorine gas. Forms unstable compounds with alkalis.
