### Description of first aid measures

#### If inhaled

## SECTION 6: Accidental release measures

### Personal precautions, protective equipment and emergency procedures

### **Persistence and degradability**

AEROBIC: After 2 weeks of exposure to different bacterial cultures incubated at 25 deg C in both moist and submerged soil, pentachloroaniline did not degrade(1). ANAEROBIC: Using a sulfate reducing sediment taken from the Tsurumi river Japan, pentachloroaniline degraded step wise from 2,3,4,5-tetrachloroaniline, 2,3,5-trichloroaniline, 3,5-dichloroaniline, 3-chloroaniline to aniline. Pentachloroaniline degrades through preferential ortho chlorine removal displaying a rate constant of 0.017 day<sup>-1</sup> with a half-life of 40 days(2).

### **Bioaccumulative potential**

A BCF of 363(1) and 6026(2) were reported for pentachloroaniline using guppies over a 10 day period in a flow through system and a static system, respectively. According to a classification scheme(3), this range of BCF for pentachloroaniline suggests the potential for bioconcentration in aquatic organisms ranges from high to very high.

### **Mobility in soil**

The Koc of pentachloroaniline is 41,687(1) in soil. According to a classification scheme(2), this Koc value suggests that pentachloroaniline is expected to be immobile in soil. Anilines (aromatic amines) are expected to bind strongly to humus or organic matter in soils(3,4) due to the high reactivity of the aromatic amino group(SRC).

### **Disposal methods**

#### **Product**

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

#### **Contaminated packaging**

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
