

Keep away from alkaline materials, strong bases, strong acids, oxoacids, epoxides. Absorbs moisture from the air forming a corrosive syrup. Corrosive to active metals, such as aluminum, copper, and zinc.

Add strong alkaline hypochlorite and react for 24 hours. Then flush to sewer with large volumes of water.
