#### General advice

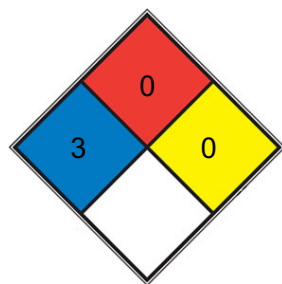
