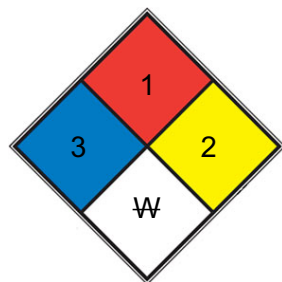

Body Protection
